## MINUTES OF THE MEETING

A Meeting was conducted with alumni from the B.A. LL.B. (Hons.), LL.M. and Ph.D. programs on Saturday, 5-11-2022 at 11:15 am in the Room No. 506, Academic Block, NLU Delhi.

The following points were discussed in the meeting:

- 1. The meeting commenced with the welcome address in which the agenda of the meeting was also laid out.
- 2. The importance of guidance of the current students by the alumni and streamlining the working of the Alumni Association were discussed by the Vice- Chancellor (I/c) in her address.
- 3. In the open house discussion, number of suggestions were given to activate the Alumni Association which are as follows:
  - a) The University will create an Alumni Page on the University website for easy connectivity with the Alumni. This can be used to make announcements and publication on the webpage will constitute sufficient notice for future activities.
  - b) It was discussed that an event can be planned for felicitating the 10<sup>th</sup> anniversary of the first batch of NLU Delhi.
  - c) The University will upload the Trust Deed on the Alumni webpage on the University website.
  - d) The University will make the interim rules for the conduct of the first election of the Alumni Association. After the elections, the Governing Body may amend/change the rules.
  - e) Before the elections, there is a need to complete the provisional membership of the Alumni Association.
  - f) The alumni will have to register on the webpage and provide their email id/phone numbers/LinkedIn id, etc. This will be provisional registration, only for the purpose of conducting the first election. Final registration will be subject to payment of membership as decided by the elected Governing Board.
  - g) Only those members who will register themselves on the Alumni webpage will be eligible to participate in the first elections.

- h) The University and the alumni members have undertaken upon themselves to publicize the Alumni Webpage so that maximum alumni can update their contact details on the portal.
- i) It was highlighted that there is a need to amend finance related clauses in the Trust
- j) The Draft Rules for Election will be uploaded on the website so that anyone who wants to suggest some modification/change may submit it through the Alumni webpage.
- k) A timeline to undertake the above mentioned task has also been decided:
  - I. Creation of Portal and uploading the information November 20, 2022
  - II. Publicity & circulation of the portal among the Alumni December 15, 2022
  - III. Publication of Interim Rules on the Website December 20, 2022
  - IV. First Round of online discussion/debate on Interim Rules January 7, 2023
    - V. Second Round of Discussion/debate January 21, 2023
  - VI. Voting and final discussion and signature on Rules February 5, 2023
